Updated Property Tax/Rent Rebate Program in Effect – Help is Available to Get You Enrolled!

New legislation increased the maximum rebate amounts and income limits for the Commonwealth's Property Tax & Rent Rebate (PTRR) Program. More Pennsylvanians over the age of 65, who are permanently disabled ages 18-64, or widow/widower over 50 will be eligible this year.

Governor Shapiro joined me in Bethlehem earlier this year to kick-off the rollout of the updated program. PTRR has been a life saver for so many seniors to help them stay in their homes and apartments. With this new expansion, nearly

Senator Boscola Applauds Governor Shapiro's Economic Development Plan

For too long Pennsylvania's economic development policy has not been a priority. Our "strategy" has been reactive, not proactive. We do a tax credit program here or a tax credit program there, but there was no overall investment and certainly no clear vision. Governor Shapiro changed that and I couldn't be more pleased.

Governor Shapiro came to Bethlehem to announce a new 10 year economic plan to drive future development in Pennsylvania. We have the best schools, the best workforce and we need to make sure that our residents have the best opportunities. Government investment can help existing businesses grow, invest in new businesses of tomorrow or encourage businesses to relocate to Pennsylvania, which will help build the economy of tomorrow.

Whether it is reclaiming an old steel mill, investing in a company's new idea or rebuilding an urban core, government, specifically state government, can play a meaningful role. Boscola Bill Adding Protection to Bald and Golden Eagles Becomes Law

The bald eagle has been our nation's symbol since 1792. The eagle has been the focus of one of the greatest conservation efforts of our state and nation's history. Their population was near extinction due to poaching, hunting, pesticide use, habitat destruction and other dangers throughout the 20th century. While regulations and protective efforts were successful for the population's rebound in recent decades, and they have officially been removed from the threatened species list, they still need to be protected.

I introduced this legislation to increase the fine from \$200 to \$2,000 in each instance of someone killing an eagle. This fine per bird would be designated towards replacement costs here in the Commonwealth. With the successful return of the bald eagle off the endangered list, more and more will be seen in the wild. I wanted to send a message to potential poachers – 'You cannot afford this. This is being taken seriously."

Senator Boscola Lauds Success of 'First In Math' Program

The First In Math program has had tremendous success for elementary school students in the district I represent. Students in 35 schools throughout the 18th District that participate in the program saw a 4.1% increase in state-level assessments, the Pennsylvania System of School

Assessment (PSSA), for math compared to the statewide average of a 2.6% increase.

I firmly believe that improving math skills in elementary school students is critical to their long-term academic success and it is why I worked to secure state funding to bring First In Math to schools throughout my district. To see students who are in schools with First In Math performing at a level that is 57% above the statewide average is proof that this is a wise investment of state funds.

First In Math is a great supplemental resource that school districts may utilize to improve a student's fluency in mathematics, as well as improving attitudes and classroom confidence. First In Math features hundreds of engaging math games designed to strengthen fact fluency, automaticity, computational thinking and other critical skills.

NOTEWORTHY HIGHLIGHTS: 78% of schools saw an increase in scores; 20 schools outperformed the PA state average; 4 schools saw a double-digit increase in PSSAs; Wilson's Avona ES had a 29.2% increase in PSSA math scores.

These results prove that First In Math benefits the students who utilize it. It truly makes math fun, supports independent learning, helps to develop students into problem solvers, and will pay dividends for our future.
